#### Why Proper Tax Preparation is Important

- Properly filing your taxes with both the State and Federal governments is a common practice every year in the U.S., but filing them properly can keep you from experiencing potentially negative consequences.
- Remember! Even if you are self-employed, doing gig-work (Uber, Lyft, DoorDash, etc.), an independent contractor, or are receiving income in any other way besides from a company or organization that provides standardized tax deduction, you still have to file a tax return!
- If you fail to file a return, or if you file your return incorrectly, this could cause the IRS to audit your taxes, which is a long and costly process, and could result in fines.

#### Tax Assistance Programs in RI

##### Volunteer Income Tax Assistance (VITA)

FREE tax preparation services through the Volunteer Income Tax Assistance program (VITA) are available for individuals and families with incomes less than \$67,000. ##### Tax Counseling for the Elderly (TCE)

The Tax Counseling for the Elderly (TCE) program offers FREE tax help to individuals who are age 60 or older. Tax return preparation assistance is provided to elderly taxpayers during the normal period for filing Federal income tax returns. ##### AARP Tax-Aide

##### IRS Free File

##### TurboTax Free E-File

For individuals with simple returns, TurboTax offers free filing for both state and federal tax returns. #### Dates to Remember for Tax Season

##### 2026

- **Jan. 2026: Tax Season begins.**
- **Feb. 2, 2026: Due Date for Employers to send out W-2s and certain 1099 forms**
- **April 1, 2026: Required minimum distribution due if you turned 73 in 2025**
- **April 15, 2026: Tax Day (Last day to file your 2025 tax returns!)**
